

## **Provider Access Policy**

#### Introduction

This policy statement sets out the school's arrangements for managing the access of providers to students at the school for the purpose of giving them information about the provider's education or training offer. This complies with the school's legal obligations under Section 42B of the Education Act 1997. Ruskin High School Provider Access Policy complies with the changes to this legislation as from 1<sup>st</sup> January 2023.

#### Enabling encounters with further education (FE) and higher education (HE)

#### Student entitlement

Ruskin High School is committed to provide impartial careers information, advice and guidance for all its pupils. It is important for pupils to be able to make informed choices based on the full range of learning and training routes available to them.

The updated Provider Access Legislation specifies that schools must provide at least four (years 8 – 11) 'provider encounters' that take place during the school day. At Ruskin, we understand that it is these encounters that will help our pupils to understand and take up not just apprenticeships but also wider technical education options such as T levels.

## **Pupil Entitlement**

Years 8 & 9 – Two encounters for pupils during the 'first key phase' These will take place any time during Year 8 and before February of Year 9.

# Years 10 & 11 – Two encounters for pupils during the 'second key phase' that are mandatory for all pupils to attend.

These will take place any time during Year 10 or between 1<sup>st</sup> September and 28<sup>th</sup> February of Year 11.

## The purpose:

- to find out about technical education qualifications and apprenticeships opportunities, as part of a careers programme which provides information on the full range of education and training options available at each transition point;
- to hear from a range of local providers about the opportunities they offer, including technical education and apprenticeships through options events, assemblies and group discussions and taster events;
- to understand how to make applications for the full range of academic and technical courses.
